



Health Warranty and Purchase Agreement

A non refundable deposit of \$300 is required for a male or female dog sold under this contract. The dog is sold as a pet only and cannot be bred under this contract. Puppy is to be paid in full by 4 weeks of age unless other arrangements made.

Seller's Responsibility:

1. The Seller guarantees the puppy is in good health, and up-to-date on immunizations and de-worming at the time the Buyer takes possession.
2. The Buyer will have the puppy examined by a licensed veterinarian within three business days. If the puppy is found to be in poor health with a pre-existing condition, the Buyer has the option of returning the puppy to the Seller at Buyer's expense for a full refund, or keeping the puppy. The Seller will reimburse veterinary costs up to half the purchase price related to treatment of said pre-existing condition. If the puppy is not taken to a licensed veterinarian within the designated timeframe, the Healthy Warranty is void.
3. The Seller provides this warranty for 24 months after the date of sale against any debilitating congenital defects, including hip dysplasia. In the event the puppy exhibits symptoms of a suspected debilitating congenital defect, the Buyer must supply all requested veterinary records to the Seller. The Seller may request an examination from the Seller's veterinarian.

4. If the puppy dies within 24 months, an autopsy must be performed at the Buyer's expense by a licensed veterinarian. If the autopsy results indicate a congenital issue, the Buyer may request a replacement puppy from the next available litter of equal value of the Seller's choosing. Alternatively, the Buyer may request reimbursement of the puppy's full purchase price. The Health Warranty is void if the autopsy results are inconclusive.

5. Illnesses due to Buyer negligence (including injury, or putting undue stress on joints through excessive weight gain or over-exercise) will not be reimbursed.

6. If a genetic disorder is identified within 24 months of purchase, the Buyer may request a replacement puppy from the next available litter of equal value of the Seller's choosing. Alternatively, the Buyer may request reimbursement of up to half the purchase price for veterinary expenses related to that illness.

7. This warranty does not include viral or bacterial illnesses, hernias, or medical issues generated from vaccinations.

8. The Seller agrees to have a licensed veterinarian perform the following prior to sale at no cost to the Buyer:

- a. Spay or neuter
- b. Microchip puppy
- c. Vaccination
- d. De-worming treatment
- e. Health exam

9. In the event the Buyer cannot care for the puppy, the Seller has the right of first refusal, and the Buyer will not turn the puppy over to an animal shelter or research facility. If the Buyer returns the puppy within the first seven days, the Seller will reimburse the total cost of the puppy, minus the \$300 deposit. If the Buyer returns the puppy within the first 30 days, half the total cost of the puppy will be reimbursed, minus the \$300 deposit. If the buyer returns the puppy any time after the first 30 days, the Seller will accept the puppy for re-homing with no reimbursement.

10. No warranties or guarantees, expressed or implied, are made under its contract except as stated.

11. This warranty is non-transferable.

Buyer's Responsibility:

1. The Buyer agrees to pay the Seller a total sum of \$_____, excluding any shipping fees.

2. The Buyer agrees to ensure the puppy will be seen by a licensed veterinarian within three days of receipt of puppy.

3. The Buyer agrees the puppy will be housed indoors.

4. The Buyer agrees to maintain the puppy's weight into and throughout adulthood.

5. The Buyer agrees to ensure the puppy will be seen by a licensed veterinarian each year for preventative health care, and ensure all vaccinations and heartworm are kept current.

6. The Buyer agrees to provide basic obedience training within four months (16 weeks) of purchase.
